MINUTES

Chair Mollenhauer called the meeting to order at 4:30 p.m.

Chair Mollenhauer declared the meeting open regarding the Kirkwood Community College 2023 Sidewalk Extension Project. There being no questions or comments, Trustee Stamp and Caves moved and seconded the hearing be closed. Motion carried: 6-0.

Trustees Jensen and Pearson moved and seconded approval of the minutes from the meeting held on December 8, 2022, and directed them to be made a part of the permanent record. Motion carried: 6-0.

Trustees Caves and Stamp moved and seconded approval of the January 12, 2023 agenda. Motion carried: 6-0

INFORMATIONAL ITEMS

Kirkwood Report

Justin Hoehn, Director of Media and Legislative Relations, provided the Eagle Update and Kirkwood report, which included:

- The spring semester begins on Tuesday, January 17... culminating with Commencement on the 13th of May.
- Student of the month is Carson Brincks. Carson is from Ossian, Iowa and graduated from South Winneshiek High School. Because of dual enrollment, he also graduated from Northeast Iowa Community College with an Associate of Arts degree. Carson chose Kirkwood for several reasons: Kirkwood's Automotive program and its state-of-the-art facility and instructors with years of hands-on experience, and to pursue a degree in Agricultural Sciences focusing on agronomy and beef production. In five years, he will apply what he has learned to his work on the farm and hopes to open a small automotive shop to serve his community with quality, affordable car care.
- Kirkwood has received the association's Distinguished Budget Presentation Award for the college's budget. The award represents a significant achievement by the college.
- The Eagles women's basketball team is once again at the top of its game. The Eagles are ranked in the top three in the nation, including a stint at number 1 earlier in the season. Currently, they are 15-1 following a win over Ellsworth last night. The Eagles are the only undefeated team in conference play so far.
- The Eagles men's basketball team are also doing well. They are currently ranked 11th with a record of 14-3; the Eagles defeated Ellsworth last night.

- Kirkwood's Respiratory Therapist Program was established in 1972 through the joint efforts of Dr. John Kasik, the faculty and the administration of Kirkwood. Dr. Kasik was the Medical Director of the program for many years and had a huge impact on its success. He passed away in 2014. The program, in conjunction with the Kirkwood Foundation, is hoping to raise \$20,000 by August 2023 to create the Dr. John Kasik Memorial Endowed Scholarship to support Kirkwood Respiratory Therapy students in perpetuity.
- The Corridor Business Journal's Corridor Leaders 250 issue is now available. President Sundberg, Vice President Jasmine Almoayyed, and Amy Lasack, our executive director of Corporate Training, were all recognized.

Kirkwood's Therapy Dog

Alissa R. King, Professor-Sociology/Owner & Handler of Therapy Dogs, introduced current therapy dog, Wick. Wick, along with Dex and Shade have visited classrooms, department meetings and offices over the last five years to provide education and stress relief to faculty, staff and students.

Clery and Reporting

Jon Buse, Vice President of Student Services and Andrew MacPherson, Associate Vice President for Emergency Management and Campus Security provided an overview of the Clery Act, Title IX, and the Violence Against Women Act (VAWA) and compliance expectations and impacts on campus safety and security. The presenters reviewed the legal requirements and provided examples of how those laws impact documentation, reporting, and response at the student level. Additionally, the presenters reviewed the systems the college has in place for ensuring compliance with each statute and concluded by providing the board with information on how to report violations of the law and college policy to institutional officials.

Financial Report

Treasurer Drew provided a high-level review of planned changes to the FY23 projections that will be reviewed in detail at the February 2023 board meeting. Key item impacting FY23 revenues are lower credit revenues. Key item impacting FY23 expenditures is increased utility expenses which may be able to be offset with savings in other expenditure categories.

Initial FY24 budget items were identified which included anticipated tuition rates, taxable property valuations, and increased operating cost.

The various components of the annual property tax levy were discussed and defined. The initial FY24 property tax levy is expected to increase approximately 2.7% or \$0.036 with the majority of the increase being used to fund the continuing focus on public safety and security. The actual cost to a homeowner is expected to increase approximately 4.4% due to state changes in the property tax valuation rollbacks.

Cash balances remain very strong with the College having 112 days of cash on hand, excluding an additional 30 days of CARES cash on hand when compared to a KPI of 75 days.
