MINUTES

Chair Mollenhauer called the meeting to order at 4:30 p.m.

No public comments.

Dr. Jennifer Bradley, Vice President-Academic Affairs, recognized the Occupational Therapy Assistant Program [OTA] faculty for their work on the recent accreditation visit. Laura Green and Kim Prevo shared a brief overview of their program.

Chair Mollenhauer declared the meeting open for public hearing at 4:40 p.m. regarding the amended budget for FY24. There being no questions or comments, Trustees Caves and Thys moved and seconded the hearing be closed at 4:41 p.m. Motion carried: 8-0.

Trustees Jensen and Stamp moved and seconded approval of the minutes from the meeting held on April 11, 2024, and directed them to be made a part of the permanent record. Motion carried: 8-0.

Trustees Pearson and Thys moved and seconded approval of the May 9, 2024 agenda. Motion carried: 8-0.

INFORMATIONAL ITEMS

Kirkwood Report

Justin Hoehn, Director of Media and Legislative Relations, provided the Eagle Update and Kirkwood report, which included:

- Kirkwood's Business and IT department announced a new cutting-edge Cybersecurity and Compliance
 program scheduled to begin this fall. The program is developed through direct collaboration with
 industry leaders tailored to produce top-tier cybersecurity experts. For more information on the

- The Kirkwood Eagle baseball team is ranked number six in the country. They move on to the Region 11 tournament as the top seed. This year's tournament will be held at Harlan Rogers Sports Complex in Fort Dodge. With a first-round bye, the Eagles begin in the second round on Friday, May 10.
- The Kirkwood Eagles softball team hosted the Region 11-A tournament May 3-5 and entered as the number one seed. The Eagles are back-to-back Region 11-A Champions and Region 11 Tournament Champions for the ninth straight season. The team will host the Southeast Bobcats out of Nebraska for the District Championship on May 10-11 in a best of three game showdown. The winner will advance to the NJCAA Division II Softball World Series.

- Student of the Month: Audrey Faith. Audrey grew up in Ames, Iowa and graduated from Gilbert High School. She chose to attend Kirkwood because of our outstanding Hospitality Arts program, smaller class sizes and real-life experiences students get at the Hotel. Audrey chose this program because she loves to serve others and is a member of the American Hotel and Lodging Association through the Hospitality program.
- Spotlights and Showcases, an inaugural event, was held on April 29 and 30. The event featured 30 different groups from various areas of the college. Some of the programs and groups involved included pottery, ceramics, respiratory therapy, Surgical Technology, Architectural Technology, and graphic design... among others. Student Life Director, Seth VanderTuig and Marketing Professor Todd Saville coordinated the event.
- The baseball field was renamed in honor of former Head Coach John Lewis at a dedication ceremony on April 24.
- Kirkwood will host the 3rd Annual Mental Health Summit on May 23 at The Hotel at Kirkwood. The event is a partnership between Kirkwood and the MedQuarter here in Cedar Rapids. The summit will feature local professionals who will address specific issues and local resources for various demographics in Linn County.
- Kirkwood held the Spring Pinning Ceremony for nursing graduates on May 5. The Spring class was the largest of the post-pandemic era with 63 grads.

Financial Report

Casey Dunning, Senior Director-Finance, provided a high-level review of changes to the FY24 projected revenues for operating Fund 1 at the May 2024 board meeting for the period of July 2023 thru March 2024. Thru March 2024, credit tuition is exceeding budget by \$2.0M and contract training & non-credit tuition (less refunds) is exceeding budget by \$403K.

Overall, actual revenue is projected to exceed budget revenue by \$3.0M, however, we still have three months remaining in fiscal year 2024 so projections can change based on actual activity in future months.

Overall expenses for operating Fund 1 are projected to remain within budget for FY24. Key expense savings include Salaries and Benefits savings of \$3.1M due to savings from unfilled open positions. Additional savings are projected from utilities expenses of \$233K.

Cash balances remain strong with the College having 147 days of unrestricted days reserve at the end of April 2024, when compared to a KPI of 75 days.

Casey Dunning also provided a high-level review of the proposed credit tuition rates for AY2024-25 including a comparison of rates from AY2023-24 for all community colleges. Further update on AY2024-25 tuition rates for community colleges in Iowa will be provided at the June meeting.

Casey Dunning also provided a high-level review of the proposed budget amendment for FY2023-24.
