# KIRKWOOD COMMUNITY COLLEGE Meeting of the Board of Trustees Thursday, April 10, 2025, 4:30 P.M. Kirkwood Regional Center at the University of Iowa

#### MINUTES

Chair Pearson called the meeting to order at 4:30 p.m.

Public comments: four members of the public spoke in support of Andrea Wilson, faculty.

Chair Pearson declared the meeting open for public hearing at 4:40 p.m. regarding the FY26 Proposed Budget. There being no questions or comments, Trustees Wright and Williams moved and seconded the hearing to be closed at 4:40 p.m. Motion carried: 8-0.

#### **Student Perspectives**

Lori Brown, Associate Professor-Management in the Business and Information Technology department, introduced student speakers who recently returned from an enriching study abroad experience in Bordeaux, France. These students were selected to participate in a prestigious international project known as **"Erasmus+/6 Bridges,"** which brings together students from six higher education institutions across Europe.

The Kirkwood students collaborated with peers from five European countries on a unique academic initiative focused on Business Administration. The host institution, Lycée Brémontier in Bordeaux, extended a special invitation to Kirkwood students and faculty based on the college's strong reputation in virtual exchange and student aboard programs.

Trustees Thys and Doerge moved and seconded approval of the April 10, 2025, agenda. Motion carried: 8-0

#### **INFORMATIONAL ITEMS**

#### **Kirkwood Report**

Justin Hoehn, Director of Media and Communications, provided the Kirkwood report, which included:

- April's Student of the Month is Darren Rink, a standout student in the Paralegal program.
- It's been an extraordinary season for the Kirkwood Eagles basketball teams the women's team earned a fourth-place national finish, while the men's team claimed the national championship title! A celebration was held on April 1 to honor their incredible achievement.
- Congresswoman Ashley Hinson visited Kirkwood's Aviation Maintenance Technician program on March 28, touring the college's hangar at the Eastern Iowa Airport.
- From March 28–30, the Kirkwood Visual and Performing Arts program staged its spring production, *Silent Sky* the inspiring story of 19th-century astronomer Henrietta Leavitt.
- The Kirkwood Library launched a new and creative initiative: a Seed Library, where students can check out seeds for vegetables, herbs, and flowers just like borrowing a book!

### Kirkwood Regional Center at the University of Iowa [KRCUI] Update

Melissa Payne, Jasmine Almoayyed, and Jennifer Bradley provided an overview of the services and activities happening at KRCUI. Payne highlighted enrollment numbers, the staff and services supporting students at the KRCUI location and introduced work study student Shelby Adamiec. Almoayyed featured demographic information about the wide range of students in secondary programs, including English Language, High School Completion, and Workforce Programs. Bradley focused on credit programing in the Arts and Sciences and Health, the academic services available in the Learning Commons and Test Center, as well as the growing English Language Acquisition population.

## **Financial Report**

Treasurer Dunning provided a high-level review of changes to the FY25 projected revenues for operating Fund 1 at the March 2025 board meeting for the period of July 2024 through February 2025. Through February 2025, credit tuition is projected to exceed the budget by \$510k. Investment income is projected to exceed the budget by \$1.26M due to higher-than-expected interest rates and interest from a Certificate of Deposit investment. Overall, actual revenue is projected to exceed budget revenue by \$2.11M.

Overall expenses for operating Fund 1 are projected to remain within budget for FY25. Key expense savings include Salaries and Benefits savings of \$3.15M due to savings from unfilled open positions. Non-Capital Equipment expenses are projected to exceed budget by \$204k, these costs will be absorbed by savings in other expense categories. In total operating expenses are currently projected to end the year within budget. Fund 3 is projected to end the year with a net loss of \$117k.

Cash balances for February and March month end were reviewed. Cash Balances for February remain strong with the College having 157 days of unrestricted days reserve at the end of February 2025, when compared to a KPI of 75 days. Cash Balances for March dropped to 124 days of unrestricted cash reserve due to a timing issue related to cash outflows for the purchase of 1025 Kirkwood Parkway SW, Cedar Rapids, IA.

Treasurer Dunning also provided a high-level review of the property tax levies for FY26. The general fund reflects the operating revenue and expenditures of Kirkwood in the College's unrestricted fund and restricted fund. The general fund budget for FY26 is a surplus of \$2.73M with revenues exceeding expenditures to address a fund balance deficit in the restricted fund. Staff will be working on finalizing the operating revenue and expenditures budget with a plan to bring the final version back to the Board at its June 2025 meeting. Any adjustments will not impact the property tax levy rate as those items are set in published public hearing budget. The plant funds budget is used to pay for construction projects. The plant fund budget for FY26 is a proposed deficit budget of \$2.76M using accumulated fund balances to pay for construction costs on campus. The bond & interest fund is used to pay the principal and interest on debt and is a balanced budget with revenues equal to expenditures.

For FY26 taxable valuations have increased 3.9%, which is greater than the five-year average of 3.1%. FY26 property tax levy rate will increase to \$1.43000 per \$1,000 valuation. Comparing the FY26 property tax revenue increase of \$2.7M is greater than the five-year average of \$2.1M.
