Meeting of the Board of Trustees Thursday, June 9, 2022, 4:30 P.M. Iowa Hall Room A/B

MINUTES

Chair Mollenhauer called the meeting to order at 4:30 p.m.

Trustees Stamp and Pearson moved and seconded approval of the minutes from the meeting held on May 12, 2022, and directed them to be made a part of the permanent record. Motion carried: 9-0.

Trustees Williams and Jensen moved and seconded approval of the June 9, 2022 agenda. Motion carried: 9-0.

INFORMATIONAL ITEMS

Kirkwood Report

Justin Hoehn, Associate Director of Marketing, provided the Eagle Update and Kirkwood report, which included:

- Kirkwood's commencement ceremony was held at the Alliant Energy Powerhouse in downtown Cedar Rapids on Saturday, May 14, 2022. The community recognized the academic achievements of more than 1,800 students who graduated.
- The Interior Design students at the college held the 2022 Kirkwood Interior Design Portfolio Exhibit and Gala at the Harmac Building in Cedar Rapids on May 13, 2022. The Portfolio Exhibit and Gala is a huge event for graduating Interior Design students and serves as their final project in the program. Close to 300 attendees from around the state and beyond were on hand to take a look at the great work including some of the largest national employers in Interior Design and Architecture.
- Student of the Month is Danielle Gould. Danielle is from West Branch, lowa and heard amazing things about the Kirkwood Nursing program while at her job as a CNA at the University of Iowa Hospitals and Clinics. Danielle wants to be a nurse because she has a strong desire to help people get through tough times.
- Kirkwood Visual and Performing Arts will be partnering with the Cedar Rapids Community Orchestra
 beginning this fall to offer Symphony Orchestra to Kirkwood Students. Kirkwood is currently the only
 community college in Iowa that holds accreditation from the National Association of Schools of Music, as
 well as articulation agreements in music to the University of Iowa School of Music and Coe College. With
 this partnership, along with a new Associate of Applied Arts in Music degree, even more opportunities are
 available for Kirkwood music students.
- The Kirkwood baseball team had a great season this year making it all the way to the NJCAA Division II World Series in Enid, Oklahoma, as the sixth seed. They were eliminated from competition with two straight losses. The Eagles finished in the top 10 nationally and ended the campaign with a 43-18 record.
- The softball team also had a trip to the NJCAA Division II World Series in Oxford, Alabama. The Eagles were the seventh seed at the tournament and went 5-2 in the World Series, highlighted by a 4-1 victory over top-ranked DMACC in an elimination game. The Eagles finished the tournament in third place and ended the season with a 49-18 record.
- Tamara Alt provided information regarding the Business & IT Art Piece and the meaning behind it.

Financial Report

Treasurer Choate provided an update that the FY22 projection shared at the May meeting would remain materially the same at just over a \$9 million net income due to the HEERF funding revenues. Choate provided a detailed overview of the HEERF Lost Revenue calculation showing that the College lost just over \$33 million due to the COVID pandemic. Total HEERF funding was just over \$25 million.

As of May 31, 2022, the College cash position remains strong at 183 days. Choate indicated he would be bringing the Foundation donation to the July board meeting for approval.
