## MINUTES

Chair Mollenhauer called the meeting to order at 4:30 p.m.

No public comments.

Chair Mollenhauer declared the meeting open for a public hearing at 4:31 p.m. regarding the amended budget for FY23 and the Kirkwood Community College Aeronautics Hangar Renovation. There being no questions or comments, Trustees Wright and Williams moved and seconded the hearing be closed at 4:32 p.m. Motion carried: 9-0.

Trustees Thys and Jensen moved and seconded approval of the minutes from the meetings held on April 13 and May 4, 2023, and directed them to be made a part of the permanent record. Motion carried: 9-0.

## INFORMATIONAL ITEMS

## **Kirkwood Report**

Justin Hoehn, Director of Media and Legislative Relations, provided the Eagle Update and Kirkwood report, which included:

- On May 4, 2023, Board of Trustees Chair Jim Mollenhauer introduced Dr. Kristie Fisher as the sixth president in Kirkwood's history. Currently the president of Iowa Valley Community College in Marshalltown, Fisher has served in that role since 2019. She returns to Kirkwood after having served two previous stints at the institution. Dr. Fisher will begin serving in her new role this fall.
- Kirkwood's commencement ceremony will be on May 13th at the Alliant Energy Powerhouse in Downtown Cedar Rapids.
- Student of the Month: Brendan Schnoebelen. Brendan currently attends Highland High School in Riverside. He started going to Kirkwood to earn college credit in high school to save on future college tuition. At Kirkwood, Brendan is in the Liberal Arts Academy and was drawn to it because of the benefits of taking many classes from different areas such as economics, history, composition and even religion. As part of the academy, Brendan has been able to earn 42 college credits before graduating high school. He plans to attend the University of Iowa studying Journalism and Mass Communications following high school.
- KCCK hosted the 2023 Taste of Jazz on April 28<sup>th</sup> at The Hotel at Kirkwood Center. The event was done in collaboration with Kirkwood's Culinary Arts and Hospitality Arts Departments, and it was an evening of food, wine, beer and music to benefit KCCK's Jazz Education Programs.
- David Brown has been tabbed as the new head coach for the Kirkwood Eagles volleyball team. He most recently served as the athletic director of the Fall River School District in Fall River, Wisconsin. Brown comes to Kirkwood with an extensive collegiate volleyball background, including multiple NCAA Division I-level coaching positions. Long-time head coach Jill Williams announced her intent to retire later this year.
- The 16th-ranked Kirkwood baseball team swept a three-game series from Marshalltown and claimed the No.3 seed for the regional tournament in Burlington this week. With the series victory, the Eagles have now won eight-in-a-row and are 36-16 as they head into the postseason.
- The Eagles softball team played in the Region 11-A tournament this past weekend and, despite being the number one seed, they ran into a little trouble. In the opening game of the tournament, the Eagles fell to Iowa Central by a score of 3-2, which meant if they lost one more time, their season was over. But the team clawed their way back to face Iowa Central for the title. Since they lost the first game, in order to claim the crown, they needed to defeat Iowa Central twice. The team prevailed twice, winning 8-6 and 2-0. With the second victory,

the Eagles are now the Region 11-A champions. Kirkwood will host Dawson Community College out of Glendive, Montana, in a best of three series beginning tomorrow. The winner will advance to the national tournament in Spartanburg, South Carolina later this month.

• The Kirkwood Washington County Regional Center will host their annual Kirkwood for Kids Summer camp June 19-22, 2023. This year, the camp has been revamped for the kids in Kirkwood's southern-most service area, and will feature different types of experiences depending on age group.

## Kirkwood College Credit in High School

Kristy Black, Executive Dean, K-12 Partnership Programs provided an overview of College Credit in High School programming. The presentation included important updates related to program participation and added supports aimed at student success through the department's KPI. The development of a data profile to assist with strategic planning is also helping the program with future enrollment growth. Enhancements to Career Academy programs were discussed, including registered apprenticeship options with a \$1.2 million dollar grant from the state.

#### **Financial Report**

Treasurer Drew provided a high-level review of changes to the FY23 projected revenues at the May 2023 board meeting for the period of July 2022 thru March 2023. Thru March 2023 credit tuition, fees, and sales & services are trending below budget.

Overall revenue is projected to decrease \$430K. Key items impacting FY23 revenues include lower credit revenue of \$1.4M and decrease in food & beverage sales of \$403K related to the hotel and campus café. This decline in revenue id being offset by increases in revenue related to increased enrollment for contracted training and non-credit tuition (\$663K) and increase in interest revenue (\$800K).

Overall expenses are projected to decrease \$1.7M. Key items impacting FY23 expenses include wages and benefits decreasing \$2M due to open positions currently not filled. Operating expenses are projected to be \$587K below budget and non-operating expenses are projected to be \$894K above budget.

Cash balances remain very strong with the College having 129 days of cash on hand, excluding an additional 28 days of CARES cash on hand when compared to a KPI of 75 days.
