Student Perspectives

Melissa Payne, Vice President-Student Services, introduced Emily Naughton, a sophomore from Raymond, Iowa, and a standout member of Kirkwood's volleyball team, currently ranked 4th in the nation. Emily is pursuing a degree in Liberal Arts and plans to transfer next year to continue both her athletic and academic journey, with the goal of majoring in Sports Management. In addition to excelling on the court, she serves as a representative of the volleyball program on the Student Athlete Advisory Committee, has earned recognition on the Academic All-Region Team, and contributes to the Kirkwood community through her part-time work in Johnson Hall and at the Kirkwood Rec Center.

INFORMATIONAL ITEMS

Kirkwood Report

Justin Hoehn, Director of Media Relations and Communications, provided the Kirkwood report, which included:

- Lama Mohamed, an international student from the Sudan studying Liberal Arts, has been named the October Student of the Month.
- Kirkwood's Hospitality Management program has been named the 2025 Champion of the Year by the Iowa Hotel & Lodging Association.
- Kirkwood is once again hosting the fall series of County Leadership Council meetings. Four of the five sessions have already taken place in Jones, Iowa, Washington, and Benton Counties.
- On Saturday, Kirkwood's Veterinary Technician program welcomed guests to its annual open house at the Veterinary Technology Center on main campus.
- Kirkwood's Horticulture Science students recently assisted with field preparations at Jack Trice Stadium ahead of the Cyclones' September 27 game against Arizona.

Community Colleges for Iowa

Monique Ellefson, Director of Strategic Initiatives for Community Colleges for Iowa, provided a brief update on Community Colleges for Iowa, legislative priorities and the upcoming Convention & Trade Show at the Des Moines Marriott December 2-4, 2025.

Fall Enrollment

Becky Weininger, Research Analyst, reported on the current enrollment for the Fall 2025 term based on the state reported compliance data.

Fall 2025 enrollment is 13,419 students, up 5% and enrolled in 111,657 credit hours, up 3% over Fall 2024. This is largely due to College Credit in High School students having increased 15%, and 14% increase in credit hours. The Fall 2025 overall student count is still 5% down compared to Fall 2019. Fall 2025 regular enrolled students saw a 1% decline in both students and credit hours.

Strategic Plan

Megan Thole, Senior Director of Institutional Planning, provided an update on FY2025 Institutional Student Success outcomes and presented the ongoing work of the FY2027-2030 Strategic Plan development. Persistence, Retention, and Full-time Completion continue to trend upward. The college continues to look for ways to best support our part-time completion rate.

Financial Report

Treasurer Dunning provided a high-level year-end review of Fiscal Year 2025 Operating Budget. Fund 1 revenue actuals were \$102.2M for Fiscal Year 2025 which was approximately \$2.6M above the operating revenue budget of \$99.6M. Key items impacting FY25 operating revenues included credit tuition revenue (\$830K above budget due to an increase in credit hour actuals compared to Fiscal Year 2024), contracted training and non-credit tuition (\$206K above budget), and investment income (\$1.3M above budget due to higher than forecasted interest rates).

Fund 1 total expenditure actuals were \$94.8M for Fiscal Year 2025 which was approximately \$4.7M under the operating expense budget of \$99.6M. Key items impacting FY25 expenses include salaries & benefits (\$2.9M under budget) and operating/non-operating expenses (\$1.6M under budget).

In total, Fund 1 generated a net income of \$5.8M in Fiscal Year 2025. Treasurer Dunning reviewed plans for how the net income may be used in the future. The \$5.8M of net income will be transferred to the College's Special Project Reserve account to allow for the funds to be tracked and allocated to strategic priorities approved by Cabinet. Potential projects under review by leadership were briefly discussed.

Fund 3 accounts that maintain their fund balance were reviewed. A detailed overview of which auxiliary operations contributed to or spent from their fund balances was provided.

Cash balances as of September 2025 remain strong with the College having 148 days of cash on hand, when compared to a KPI of 90 days.
